ADMINISTRATION

Since 2021, I have served as Associate Provost for Faculty Development. In that capacity, I direct faculty awards and recognition. About 15 awards are presented annually. I serve as the ex-officio member of—and the driver behind—the Provost’s Awards committee and the Regents Professors selection committee. I plan and emcee ceremonies and receptions for faculty, including two convocations per year as well as new, newly promoted, and retiring faculty receptions.

Since 2003, I have directed a four-person center, the NMSU Teaching Academy. This teaching and learning center is devoted to enhancing teaching, learning, scholarly writing, leadership, mentoring and diversity. I set the direction of the Academy in terms of programming; teach short courses and one-time workshops; host a half dozen outside speakers per year; manage the budget; fundraise; and build spirit among our team.

Each year, participants take advantage of 70 events, including a dozen short courses and book groups. About 700 faculty, staff and graduate students participate and 200 participate in ten or more hours of events, thus earning a membership in the Teaching Academy. Memberships last one year and are showcased in faculty annual reports and promotion and tenure packets. Since becoming director, our participation numbers have increased five-fold.

Many members and friends of the Academy are also donors. In annual gifts, members donate 40% of our operating budget per year. In future estate gifts, members and friends have donated \$1 million.

Recognition for the NMSU Teaching Academy

In a 2013 interview for the Academy newsletter, *Class Acts*, then Provost Dan Howard stated, “Teachers are traditionally isolated, and often the discussion of teaching is limited to hallway conversations. The Teaching Academy serves as a catalyst for these discussions. People can come together as a community of teachers and break down the isolation of

teaching. From my perspective, the NMSU Teaching Academy does this better than any other teaching center I've seen in the country."

Additionally, the Teaching Academy has received national or international recognition a dozen times.
